# 1. Introduction

The purpose of this COVID-19 Safety Plan (**Plan**) is to provide an overarching plan for the implementation and management of procedures by MacKillop Catholic College to support the College and its members and participants in the resumption of SATIS sport.

The arrangements set out in this Plan are intended to prevent the transmission of COVID-19 among members, participants, coaches, officials, administrators/volunteers, visitors, families, and the broader community. The Plan provides the framework to govern the general operation of MacKillop Catholic College, any facilities it controls, the playing/training behaviour of all members and participants and the monitoring and reporting of the health of attendees at MacKillop Catholic College facilities.

This Plan includes, but is not limited to, the conduct of:

- a. staged training and competition activities (sport operations); and
- b. facility management and supporting operations (facility operations).

At all times, the Plan is subject to all regulations, guidelines and directions of government and public health authorities.

# 2. Key Principles

This Plan is based on, and accepts, the AIS [Framework for Rebooting Sport in a COVID-19 Environment \(AIS Framework\)](#) and the [National Principles for the Resumption of Sport and Recreation Activities \(National Principles\)](#).

The Plan also accepts as key principles that:

- The health and safety of members, participants, coaches, officials, administrators/volunteers, visitors, families, and the broader community is the number one priority.
- Members, participants, coaches, officials, administrators/volunteers, families, and the broader community need to be engaged and briefed on MacKillop Catholic College's return to sport plans.
- Facilities are assessed and appropriate plans are developed to accommodate upgraded hygiene protocols, physical distancing, and other measures to mitigate the risk of transmission of COVID-19.
- Training cannot resume until the arrangements for sport operations and facility operations are finalised and approved, if necessary; and
- At every stage of the return to sport process MacKillop Catholic College must consider and apply all applicable State and Territory Government and local restrictions and regulations. The College needs to be prepared for any localised outbreak at our facilities, within our competitions or in the local community.

### 3. Responsibilities under this Plan

MacKillop Catholic College retains the overall responsibility for the effective management and implementation of the return to sport activities and operations outlined in this Plan.

The Principal of MacKillop Catholic College is responsible for:

- Approving the Plan and overseeing the implementation of the arrangements in the Plan; and
- Revising the Plan as required, ensuring it reflects up to date information from government and public health officials.

The Principal has appointed the following person as the MacKillop Catholic College as the COVID-19 Safety Coordinator to execute the delivery of the Plan and to act as a point of contact for information relating to this Plan:

MacKillop Catholic College expects all members, participants, coaches, officials, administrative staff, and volunteers to:

- Comply with the health directions of government and public health authorities as issued from time to time.
- Understand and act in accordance with this Plan as amended from time to time.
- Comply with any testing and precautionary measures implemented by MacKillop Catholic College.
- Act with honesty and integrity regarding the state of their personal health and any potential symptoms; and
- Monitor their health and take a cautious approach to self-isolation and reporting of potential symptoms.

### 4. Return to Sport Arrangements

As at the date of this Plan, participants are training at Level C of the AIS Framework. The Plan outlines specific sport requirements that MacKillop Catholic College will implement for Level B and Level C of the AIS Framework.

MacKillop Catholic College will transition to the training activity and facility use as outlined in Level B of the AIS Framework and the training/competition activities and facility use outlined in Level C of the AIS Framework when permitted under local restrictions and regulations.

#### 4.1 AIS Framework Arrangements

The protocols for conducting sport operations and facility operations under Level B and Level C of the AIS Framework are set out in the Appendix.

## 4.2 Roadmap to a COVID Safe Australia

MacKillop Catholic College will also comply with the Australian government's [Roadmap to a COVIDSafe Australia](#), which places limits on the type of activity that can be conducted and the number of people who can gather at facilities, notwithstanding the activities permitted by the AIS Framework (see below).

## 5. Recovery

When public health officials determine that the outbreak has ended in the local community, MacKillop Catholic College will consult with relevant authorities to identify criteria for scaling back its COVID-19 prevention actions. The College will also consider which protocols can remain to optimise good public and participant health.

At this time, the Principal of MacKillop Catholic College will consult with key stakeholders to review the delivery of its return to sport arrangements and use feedback to improve organisational plans and systems.

Min of 15 min gap between groups.</li> <li>• Training to be conducted in small groups (no more than 10 players and/or other personnel in total).</li> <li>• Treatment of shared equipment should be kept to a minimum and sanitise equipment before, during, after sessions, and use of such equipment to be limited.</li> <li>• No contact including high fives/hand shaking, no socialising or group meals.</li> <li>• Defined training areas for each training group, maintaining base density requirement of 4 square metres per person and physical distancing (&gt;1.5 metres).</li> <li>• Separation of entry and exit points to minimize gatherings of players should be considered where possible.</li> <li>• Sanitising stations (2) to be located at each venue, including entry and exit.</li> <li>• No sharing of personal equipment.</li> <li>• Personal hygiene encouraged (e.g. wash hands prior to training, no spitting or coughing).</li> <li>• Where possible for travel arrangements (e.g. physical distancing on public transport, limit carpool/taxi/Uber use).</li> <li>• Specific structure of training sessions: <ul style="list-style-type: none"> <li>– No person to person contact training drills to be conducted.</li> <li>– No more than 10 people to be involved in the drill.
